

# **SBH Elementary School Art Contest**

September 16<sup>th</sup> – October 25<sup>th</sup> 2019

### **Official Contest Rules:**

#### **Contest Overview**

Community students enrolled in kindergarten through fifth grade are invited to participate in the SBH "I Can Do Hesed, Jewish Holiday Edition" art contest to create artwork for the 2019 SBH Coloring Book. Each entry will depict a Jewish Holiday scene and may incorporate acts of Hesed.

Each winner will receive recognition and a **prize.** All artwork may be showcased on the SBH website and on social media.

The contest begins September 16<sup>th</sup>, 2019. <u>All entries must be submitted by October 25<sup>th</sup>, 2019</u> Winners will be announced in November. Contest rules and dates may be changed at the discretion of SBH.

#### **Contest Rules**

- Artwork must be submitted on or before October 25<sup>th</sup>, 2019. Late entries will be disqualified.
- Artwork must be original work created by a community student enrolled in kindergarten through 5<sup>th</sup> grade.
- Each student may submit only one work of art.
- Each student's parent or legal guardian must fill out and sign the Contest Entry Form and Agreement. Any artwork submitted without the Contest Entry Form and Agreement will be disqualified.
- The student's name must be written in pencil *only* on the back of artwork. Names should not appear on the front of the artwork.

- Each piece of artwork must be submitted with a Contest Entry Form and Agreement. Artwork should not be folded or damaged.
- All submitted artwork is owned by SBH. Winners agree to the use of their names/pictures to promote the SBH "I Can Do Hesed" Coloring Book and other SBH programming. Entries will not be returned. See Contest Entry Form and Agreement for further details.
- No obligation or liability is assumed by SBH in connection with the contest.

## **Eligibility**

Applicants must be students in grades K-5 as of September 4<sup>th</sup>, 2019, and must comply with these Official Rules.

## **Design Rules**

- All entries should promote the SBH mission:
  - "Kindness through service delivered with care, compassion and a commitment to excellence. To improve and maintain the health and well-being of individuals and families helping them lead productive and independent lives. Committed to the dignity, worth, and abilities of each person".
- Entries should illustrate a Jewish holiday scene and may incorporate acts of hesed. No company logos, product brands, brand names, characters (i.e. Mickey Mouse, Barbie, Teenage Mutant Ninja Turtles, etc.) or store names are allowed (i.e. Coke, 7-Eleven, etc.). Generic terms such as "restaurant" or "store" may be used.
- The student's name must be written in pencil *only* on the back of artwork. If selected, the winner's name will be printed next to his or her design.
- Artwork should be submitted on an 8.5" x 11" piece of paper (in portrait format).
- Entries should not be framed or mounted.
- All artwork should be two-dimensional, using any of the following: watercolor, acrylic or oil paints, colored pencil, colored markers, ink, charcoal, pastels, and crayons. Collages, computer-generated artwork, photography, traced images or photocopies will be disqualified.

## Judging

- Entries will be judged based on creativity/uniqueness, inclusion of a holiday message, overall visual appeal, composition, and age appropriateness.
- All judgments are final.
- Entries will be judged by an SBH appointed committee.

#### **Prizes**

Two winners will be selected.

- One winner from kindergarten through 2<sup>nd</sup> grade and one winner from 3<sup>rd</sup> through 5<sup>th</sup> grade will be chosen.
- The two winning designs will be featured in the SBH "I Can Do Hesed Jewish Holiday Coloring Book". The winners will be recognized.
- All contest entries may be showcased online.

#### **Artwork Submission**

All submissions of original designs must be dropped off with accompanying signed Parental Contest Entry Form and Agreement to SBH Offices on or before October 25<sup>th</sup> 2019.
